

EUROPEAN PARKING REGULATIONS

Parking in the parking lot is permitted only to authorized heavy goods vehicles and company cars 24 hours a day, 7 days a week. Unauthorized vehicles will be towed or impounded.

The parking lot is equipped with video surveillance for both the outdoor area and the service areas.

The parking lot is freely accessible, while the restrooms (bathrooms, showers, and relaxation area) can be used upon payment of a €3.00 fee.

Access to the area and restrooms is permitted only to parking users and their companions. The MANAGER may employ designated and specialized personnel to remove, with the assistance of law enforcement, any persons found inside the parking lot who cannot prove they are users of the parking lot.

It is prohibited to bring vehicles carrying flammable or otherwise dangerous goods, materials, or substances.

Parking is the responsibility of the user, who will be liable for any damage caused to vehicles and property in the parking lot. Compliance with the Highway Code is mandatory within the parking lot.

Vehicles may be moved for service purposes. Vehicles parked outside of designated spaces may be towed, at the user's expense and risk.

Vehicles may not be parked for more than 7 days. The MANAGER reserves the right to tow the vehicle after having completed all necessary and appropriate procedures in accordance with the law. In the event of towing or impoundment, the vehicle may be recovered or released upon payment of the MANAGER's costs.

The parking lot is unattended, and therefore the MANAGER is not responsible for theft and/or damage caused to one another by parking users or third parties, or caused by acts of vandalism.

Records of damage and/or accidents are retained by the MANAGER for 7 days and may only be accessed by law enforcement.

By parking the vehicle, the user acknowledges having read and accepted the rules contained in these regulations.
